

## Powell Police Department's Basic Handgun and Concealed Carry Course Application:



Applicants are required to return the completed application for admission no **later than 3 business days** prior to the beginning of the class. A background check and criminal history will be completed for all Applicants. Applicants who do not meet the minimum requirements **will not** be allowed to participate.

There is a limit of 12 students per course and will be accepted on a first-come, first-serve basis.

This is an 8 hour course consisting of approximately 2 hours of class instruction and 6 hours at the Heart Mountain Rod and Gun Club Range.

Class participants will begin the course at the Powell Police Department on Saturday, September 27, 2014 at 8:00 a.m.

### **RULES OF THE CLASSROOM:**

- **DO NOT BRING A LOADED FIREARM TO CLASS.** Bring your handguns in a case **ALONG** with the holster you plan on using at the range.
- Absolutely **NO AMMUNITION** during the class room portion of this course.
- Bring a notepad and pen to take notes, and to write down any questions you may have.
- Please **HOLD** your questions and comments until the end of class. Chances are your questions will be answered in the normal course of the presentation.
- You are asked to arrive at the very most 15 minutes prior to class time, and are expected to exit the building directly after class unless you are accompanied by an Instructor/Officer.
- Students are permitted to be in the downstairs classroom and restroom area of the Police Department. Instructors or Staff will escort students in and out of the building.
- Remember that this is a large class combined with the fact that the Instructors have a lot of material to cover.
- Feel free to get a cup of coffee or use the restroom at any time.



## RULES AT THE RANGE:

- The Instructors reserve the right to excuse anyone who is consistently violating the range rules/range safety from participating in any block of instruction. 3 strikes rule: The first range violation students will be corrected with instruction. The second, students will be asked to unload your handgun and step off of the line until an Instructor can speak with you. If a student commits a third violation, they will be asked to leave the range, and will not be awarded a certificate of completion for the course. Our goal is to provide students with SAFE instruction and training.
- DO NOT BRING A LOADED FIREARM TO THE RANGE. Please ensure that your firearms are unloaded prior to arriving at the range.
- Bring your holster/concealed carry holster to the range. **YOU MUST** have a holster to participate in the range portion of this course.
- Bring your own ammunition. You will need at least 200-300 rounds of factory ammunition for your firearms. If you cannot bring factory ammunition, reloads are permitted.
- Eye and ear protection is required while operating on the range.

# Powell Police Department's Basic Handgun and Concealed Carry Course: Application of Admission.



Applicants for the course must meet the following requirements:

- Minimum age of 21 years.
- No prior felony convictions.
- No misdemeanor arrests within two years of the application.
- Must have a valid Wyoming driver's license or Wyoming identification card.
- Must be a resident or business owner in Park County.
- Must complete a notarized Release of Claim and Statement of Eligibility Form.

Clark Street, Powell, Wyoming. A \$10.00 fee will be assessed per application. This fee will be used for course materials and refreshments.

## Release of all claims and statement of eligibility

RELEASOR expressly agrees that this release and waiver is intended to be as broad and inclusive as permitted by the laws of the State of Wyoming and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in force and effect.

This release contains the entire agreement between the parties hereto and the terms of this Release are contractual and not a mere recital. RELEASOR further states that I have carefully read the foregoing Release, as well as the information stated in the "Instructions/Expectations" section, and know that contents thereof and sign this release as my own free act.

RELEASOR further swears and attests to that RELEASOR has not been convicted of any prior felony offense punishable by imprisonment of more than one year, is eligible under all laws of the United States of America and The State of Wyoming to lawfully possess a firearm and that all information contained in this application is true and correct.
